Meeting schedule of dates and times have been approved unanimously by all those present.

We need to approve a format for public comment (up to 20 minute per meeting). Two minutes per person should be allowed for community members or GO Team members to provide commentary. Meetings for public commentary have been designated and agreed upon. Sign-up sheets will be provided 15 minutes prior to the meeting for individuals to sign up to speak.

We need to agree upon our Team Norms. A motion is made to add to our norms, “We will work to take into account our stake holders as a community in decision making”. The team unanimously approves to adopt the amended norms as shared.

DLI discussion as to far as concerns relative to admission dates. A meeting has been set up by Mrs. Abbott in September with Student Placement and Dr. McKenzie in the Office of World Languages to share these concerns. Concerns were raised by community member/parents at the May meeting as to the DLI admissions process and dates. Mrs. Abbott clarifies the issues, charts the concerns and the team discusses possible resolutions.

We continue to seek resolutions to propose to Student Placement as to timelines of acceptance. We’d like to ask for an early admission for families who are in-zone, to align with other local schools. This will assist families in making decisions as to enrollment.

It is also suggested that we speak to the community about Dual Immersion and what the program entails, so that families have clarity as to the model, the expectations and the commitment to the program through 5<sup>th</sup> grade.

Parent DLI meetings will be scheduled by grade level this school year.
